Purpose of the role

The Estates Division, Estate Facilities Section is responsible for the Maintenance of the University's operational estate which includes a wide variety of property with a total insurance replacement value of £1.6 Billion. The Estate has in excess of 6,000 maintainable assets within over 365 operational buildings. The Section provides planned preventative Maintenance and long term development of services as well as a "round the clock" reactive Maintenance service. Total expenditure covered by the Maintenance Section in 2014/15 was in excess of £16M.

3,500 stock lines are held in store out of a range of in excess 10,700 items. The stock value held in store is £184,000 (2014). Annual turnover of stock value is £900,000 (2014).

A wide range of materials from the Construction industry are purchased including:

- Electrical category ranging from socket outlet to light fittings;
- Plumbing category including hot and cold water and above & below drainage systems;
- Heating systems category including boilers, pipe work, radiators and air handling units;
- Controls category dealing with commercial building and airconditioning components;
- Building category including timber, paints and tools; and
- Horticultural category including seasonal bedding and chemicals.

As part of the Purchasing & Supplies team, the role holder will

- Obtain quotes for goods and services
- Raise purchase orders from requisitions
- Maintain levels of stock in the Stores
- Support the Purchasing and Supplies Coordinator in their day to day activities.
- Provide a Stores Counter service
- Manage the provision of PPE



Additionally, the Role Holders will support the Fleet Manager through carrying out other tasks if required:

- Drives the Prime Mover SUV to move equipment, clear snow, and pull the fuel bowser
- Refuels generators
- Waste collections (such as pallets for recycling)
- List of portable items such as heaters
- Supports a parts & equipment collection and delivery service
- forklift truck weekly checks
- Bicycle collections for repairs

Key Responsibilities

Purchasing

To raise Purchase Orders for goods and services on the Planet and CUFS systems both from requisitions and stock shortages reports. It is important to ensure that stock does not fall below the minimum levels and that requests for non-stock items are met within the priority given on the requisition.

To update the items table on Planet when required, to include new items (avoiding duplications) and to update manufacturer's codes etc.

To provide the Purchasing & Supplies Coordinator with support such as filing and other administrative tasks to enable an efficient purchasing service and to maintain stocks of stationery.

To manage the PPE issue processes

Stores

The role holder will help to ensure that the Stores Counter is covered from 08:30 to 17:00 daily. Stores work includes counter service to operational staff, receiving and booking in deliveries, booking out stock to Work Orders and keeping the stores and satellite tidy and stocked to min/max levels. Regular counts of the stock are expected and all Purchasing & Supplies staff are involved in the full stocktake on fixed dates twice a year.

The role holder is encouraged to suggest and to help implement process improvements and to assist with keeping work instructions up to date

Responsibility for safe secure storage and transportation of hazardous materials such as compressed gas bottles including nitrogen, oxygen, acetylene and various refrigerant gasses. Is familiar with the legal documentation and vehicle signage requirements for this work. Carries out safe and secure transportation and off-loading of water treatment chemicals, salt, inhibitors etc. Is familiar with the COSHH requirements for the safe transportation and handling of these chemicals

Support Deliveries & Collections

Collects, loads, unloads and delivers materials, equipment, tools from/to Laundry Farm, various sites and suppliers to points of use/store. Most journeys are within the Cambridge locality but long distance journeys will be required from time to time. Carries out safe and secure transportation of fabricated assemblies from Maintenance Section workshops to the various sites.

Collects and delivers personnel from/to sites around Cambridge if required.

Transports and assists with erection of ladders, scaffolding and other access equipment including operation and use of the cherry picker.

Carries out safe and secure transportation and off-loading of diesel fuel to the various emergency standby generators located throughout the University Estate using the mobile fuel bowser. Monitors usage and maintains stored fuel levels for each generator.

Estates Division

The Estates Division at the University of Cambridge is a multi-disciplinary organisation responsible for the development, management and maintenance of the University estate, along with the provision of a variety of related services.

Our current operational estate (buildings used for teaching, research and administrative activities) is currently valued at £3 billion (Insurance Replacement Cost) and its broad and complex nature presents many demanding challenges, for example some buildings are 800 years old, Grade I Listed and protected by English Heritage, whilst others are new with highly sustainable building fabrics and buildings management systems.

Key areas we are responsible for include:

- Planning and managing the University's estate development programme.
- Project managing new build construction and the refurbishment/alteration of existing stock.
- Managing and maintaining the estate including residential accommodation and investment properties.
- o Delivering a comprehensive facilities management service to the University.
- Managing catering outlets across the estate.
- Managing the operational and research facilities at the <u>University Farm</u>.
- Promoting the University's environmental sustainability initiative, particularly with regard to reducing carbon emissions.



Terms of Appointment

Tenure and probation

The appointments will be made on a permanent basis. Appointments will be subject to satisfactory completion of a three month probationary period.

Hours of Work and Working Pattern

The hours of work for the position are 36.5 hours per week, working Monday – Friday.
